## SCHEDULE OF FEES FOR 2019

Tuition Fees and Building Levy are set each year by the Diocesan Schools Board. School fees will be billed and invoiced on an annual basis by the Catholic Schools Office. The standard payment terms are in three equal instalments in February, May and July, however families can also elect to pay either yearly, monthly, fortnightly or weekly.

### TUITION FEES:

1 <sup>st</sup> child enrolled at a Systemic Diocesan School	<b>\$2057.00 per year</b>
2 <sup>nd</sup> child enrolled at a Systemic Diocesan school	<b>\$1645.60 per year</b>
3 <sup>rd</sup> child enrolled at a Systemic Diocesan school	<b>\$1028.50 per year</b>
4 <sup>th</sup> & subsequent children enrolled at a Systemic Diocesan School	<b>No charge</b>

Sibling reduction of tuition fees is available to families where siblings attend Systemic High Schools (Mater Maria College, Warriewood and St Paul's College, Manly) within the Diocese of Broken Bay and only after the Family Registration Form has been completed and returned to the office. (There is also a Tuition fee discount for Stella Maris College, Manly)

Students attending systemic schools in the Archdiocese of Sydney, Diocese of Parramatta and the Diocese of Wollongong may also be eligible for sibling discounts on tuition fees.

### DIOCESAN SCHOOL BUILDING LEVY:

The Building Levy is charged per family per year. **\$970.00**

This fee is used to maintain and/or replace the school buildings in the Diocese.

Families who are exempt from this fee at Sacred Heart are those with siblings at Mater Maria College, Warriewood and St Paul's College, Manly.

Students attending systemic schools in the Archdiocese of Sydney, Diocese of Parramatta and the Diocese of Wollongong may also be eligible for a reduction on the Diocese of Broken Bay **Building levy**.

### SCHOOL EDUCATION FEE (per child per year):

<b>Kindergarten to Year 6</b>	<b>\$945.00 per child</b>
<b>+ Years 5 and Year 6 Camp</b>	<b>\$266.26 per child</b>

This fee covers curriculum resources and materials used in your child's learning program, excursions, sport levies & school maintenance.

**\*\* Please note:** University Competitions (ICAS), Extra-curricular activities eg band, Year 6 expenses (Graduation, Jersey) are collected separately as they occur and by the relevant activity.

Accounts are emailed to families by the Catholic Schools Office at the beginning of Term 1 followed by monthly statements from the school office.

Our preferred method of payment is by BPAY. Fees can also be paid by Qkr, Cash, EFTPOS, Credit Card (Visa & MasterCard).

**RECEIPTS WILL NOT BE GIVEN UNLESS PAYMENT IS MADE BY CASH.**

Payment of fees is a condition of enrolment of your child/children in the school.

If more than one account is to be issued per family, ie split billing, written approval of **all** parties involved must be obtained – please contact the school office for details.

The Fees Liaison Team has been established at the Catholic Schools Office and follows up all families with overdue accounts. These families are contacted by a team member to discuss payment arrangements. Families who wish to discuss their situation can contact the team as below.
